



## Lifetime Glass Breakage Limited Warranty

Park Avenue® Windows & Sliding Glass Doors

*Notice: This warranty will be in effect only after it has been validated by the manufacturer.  
Mail the enclosed registration certificate within 10 days of window installation for validation.*

This Lifetime Glass Breakage Limited Warranty is a special consideration granted by the Park Avenue® Manufacturer to, \_\_\_\_\_ the owner-occupant of a single family dwelling located at, \_\_\_\_\_ subject to the terms and conditions listed below.

If a unit of clear non-decorative insulating glass manufactured by the Park Avenue® Manufacturer and installed in one of its windows or doors breaks, the Park Avenue® Manufacturer will furnish a replacement unit of insulating glass free of charge, subject to the following qualifications. It cannot exceed twelve (12) square feet in size and must consist of clear glass only, although it may have standard colonial grids between the glass. Obscure glass bathroom windows are also covered. Decorative glass or other styles of grids are not covered by this warranty. Breakage resulting from improper installation, mishandling, misuse, abuse, accidents, fire, hail, flood, earthquake, or other Acts of God, vandalism, acts of terrorism, civil unrest or other causes beyond the control of the manufacturer, intentional or otherwise are not covered.

To order a replacement unit of insulating glass, submit your warranty claim in writing to the Park Avenue® Manufacturer's address below. The claim must include proof of ownership, a copy of the original contract and factory order number. The Park Avenue® Manufacturer, or its agent, reserves the right to inspect the premises if required. The replacement glass will be shipped to the nearest designated dealer. Shipping and handling charges shall be paid by the homeowner. Pick-up must be arranged by the homeowner. This warranty is limited to the furnishing of replacement insulating glass panels and does not cover or include any labor costs. The manufacturer of Park Avenue® windows and doors will not be responsible for any costs incurred in the removal, disposal or reinstallation of the insulating glass panels or window.

Park Avenue® Manufacturer reserves the right to discontinue or change any products as manufactured. If the products covered by this Limited Warranty are not available for purposes of a warranted replacement, Park Avenue® Manufacturer shall have the right to substitute products that, in its sole discretion, are equal in quality or value.

This Limited Warranty cannot be transferred, sold or assigned to any other person. Any attempt to so transfer this Limited Warranty shall be void on its face.

BY ACCEPTANCE AND USE OF THE PRODUCTS, EACH ORIGINAL PURCHASER ACKNOWLEDGES AND AGREES THAT THE REMEDIES PROVIDED HEREIN ARE SUFFICIENT AND SHALL NOT DEPRIVE SUCH ORIGINAL PURCHASER OF THE VALUE BARGAINED FOR IN THE ORIGINAL PURCHASE. THIS WARRANTY EXTENDS ONLY TO THE DESCRIPTION ON THE FACE HEREOF. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE DISCLAIMED. IT IS UNDERSTOOD AND AGREED THAT THE PARK AVENUE® MANUFACTURER'S LIABILITY SHALL NOT EXCEED THE FURNISHING OF A REPLACEMENT UNIT OF INSULATING GLASS AND UNDER NO CIRCUMSTANCES SHALL THE PARK AVENUE® MANUFACTURER BE LIABLE FOR SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.
